## Trump sets China tariff plan, edges away from global trade war

WASHINGTON (Reuters) - U.S. President Donald Trump signed a presidential memorandum on Thursday that could impose tariffs on up to \$60 billion of imports from China, although his action was far removed from threats that could have ignited a global trade war. Under the terms of the memorandum, Trump will target the Chinese imports only after a consultation period, a measure that will give industry lobbyists and legislators a chance to water down a proposed target list which runs to 1,300 products. China will also have space to respond to Trump's actions, reducing the risk of immediate dramatic retaliation from Beijing, and Trump struck an emollient tone as he started speaking, saying "I view them as a friend."

"We have spoken to China and we are in the middle of negotiations," Trump said, adding that loss of American jobs from unfair trade was one of the main reasons he had been elected in 2016. The United States runs a \$375 billion goods trade deficit with China. Washington will also pursue alleged breaches of intellectual property law by

China through the World Trade Organization, a body that has repeatedly drawn the ire of the administration but which could provide a resolution that avoids a trade war. Global stocks had sold off on Thursday on the expectation of tough action from Trump, with U.S. markets down as much as 2 percent, but recovered somewhat after the announcement. Following Trump's announcement on Thursday, the U.S. Trade Representative's office will present a list of products that could be targeted, primarily from the high-tech sector. There will then be a 60-day consultation period before definitive action will be put into force. White House officials told a briefing ahead of the trade announcement that the administration was eyeing tariffs on \$50 billion in Chinese goods. They said the figure was based on a calculation of the impact on the profits of U.S. companies that had been forced to hand over their intellectual property as the price of doing business in China. There was no explanation of the difference between the numbers provided by White House officials in the briefing and Trump's \$60 billion.

"Many of these areas are those where China has sought to acquire advantage through the unfair acquisition and forced technology transfer from U.S. companies ... establishing its own competitive advantage in an unfair manner," Everett Eissenstat, deputy director of the National Economic Council, told reporters.

In addition, Trump will also direct the U.S. Treasury to propose measures that could restrict Chinese investments in the United States, Eissenstat said. The tariffs and investment restrictions will be imposed under the U.S. Trade Represent-

tative's "Section 301" investigation into alleged misappropriation of U.S. intellectual property by China. Eissenstat said the investigation clearly demonstrates unfair practices by China, which forces U.S. investors to turn over key technologies to Chinese firms.

# Congressman Al Green’s Statement on Funding for Fair Housing Programs

Washington, D.C. (March 20, 2018) – Today, Representatives Al Green (D-TX) and Barbara Lee (D-CA) led a letter to the Appropriations Committee with 84 members of Congress to support \$45 million in funding for the Fair Housing Initiatives Program (FHIP) and \$24.3 million for the Fair Housing Assistance Program (FHAP) for Fiscal Year 2019. President Trump’s current budget request of \$36.2 million for FHIP would leave the program significantly underfunded.

Following the tragic assassination of Dr. Martin Luther King, Jr., Congress passed the Fair Housing Act in April 1968. Unfortunately, countless Americans continue to face housing discrimination to this day. Programs like FHIP and FHAP play a critical role in educating the public and housing providers about housing discrimination and work to ensure all Americans have fair access to housing.

“I look forward to working with the Housing and Development Agency (HUD) and housing providers in my district to ensure that everyone has access to housing,” said Congressman Al Green. “As we mark the 50th

Anniversary of the passage of the Fair Housing Act, I reaffirm my commitment to making Dr. King’s dream of fair housing for all a reality.”

Congresswoman Barbara Lee said, “Housing discrimination is an urgent civil rights issue. During this 50th anniversary of the Fair Housing Act, I am proud to continue the work of the late Dr. Martin Luther King, Jr. to ensure that every American can live in the community of their choice. I also want to thank my colleague, Congressman Al Green, for working with me to eliminate racial bias in housing.”

## AUTHORITIES CONFIRM LATEST PACKAGE BOMBS ARE CONNECTED

(Austin, TX) - The Austin Police Department (APD), the Federal Bureau of Investigation (FBI), and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) are confirming that two packages located at two separate FedEx facilities in the Austin/San Antonio area on Tuesday, March 20, 2018 are connected to the four previous package explosions that occurred between March 2 and March 18, 2018 in Austin, Texas. In Tuesday’s incidents, one package exploded and the second one was disrupted by law enforcement. Schertz Police Department responded to a package explosion

at approximately 12:25 a.m. at the FedEx facility located at 9935 Doerr Lane in Schertz, TX. One person, an employee, was treated at the scene and released. FBI and ATF also responded and continue to process the scene for evidence.

Later that morning, at approximately 6:19 a.m., APD received a call regarding a suspicious package at 4117 McKinney Falls Parkway in Austin. APD, along with the FBI and the ATF, responded. It was determined the package contained an explosive device and was disrupted by law enforcement. No injuries were reported. We continue to ask the public to be vigilant. Do not approach or interact

with a suspicious person or object. We ask that you contact law enforcement and not attempt to intervene on your own. Until the individual(s) behind these package explosions is apprehended, there remains an ongoing threat to the public.

The Astrodome will be designated a Recorded Texas Historic Landmark. The iconic Astrodome is now in line for a dramatic \$105 million transformation.

The Astrodome will be designated as a Recorded Texas Historic Landmark — the highest honor the state can bestow on a historic structure.

The marker will finally and officially tell the story of the “Eighth Wonder of the World” and, officials hope, create a snapshot destination.

“The Dome has never had an actual historical marker,” said Mike Vance, a member of the Harris County Historical Commission, which is the local arm of the Texas Historical Commission.

The state agency approved the stadium’s designation in January among 172 new historical markers across Texas for 2018.

At its opening, the Astrodome embodied the height of innovation. The building was the world’s largest domed structure and the biggest air-conditioned stadium as well as the first ballpark with artificial turf, luxury suites and an animated scoreboard.

“The Astrodome is the most important building we’ve ever had in our city’s history,” said Vance, a professional historian and program director for The Heritage Society at Sam Houston Park. “It’s the most recognized and the most influential building that we’ve ever had. ... It absolutely changed architecture and engineering around the world.”

The stadium opened on April 9, 1965, to a sold-out crowd of more than 47,000 for an exhibition baseball game between the Astros and the New York Yankees. The historical marker dedication, which will be scheduled soon, comes near the Dome’s 53rd birthday.

The Astrodome received its strongest protection with a 2017 state antiquities landmark designation, giving the stadium special safeguards against demolition and requiring clearance from the Texas Historical Commission for any alterations.

Becoming a Recorded Texas Historic Landmark adds another measure of protection.

“It’s a higher standard you have to reach to qualify for that kind of marker,” Vance said. “That means that it’s a building and it has to be intact in the judgment of the Texas Historical Commission — and the Dome, thankfully, is.”

In addition, the sign’s unveiling will be “something tangible and visible,” unlike the antiquities designation, Vance said.

Preservation and renovation of the Astrodome has been a long-held priority for Harris County Judge Ed Emmett. The county is spending \$105 million to renovate the stadium. Construction is expected to begin in October.

“Judge Emmett has been supportive of the Astros and the county historical society’s efforts in putting a marker at the Astrodome from the very beginning,” said Joe Stinebaker, a spokesman for the county executive. “He has said repeatedly that The Alamo and the Astrodome are probably the two most recognizably historic buildings in the state of Texas — and if the Astrodome doesn’t deserve a historical marker, what does?”

The Astros organization, whose history is intertwined with the Astrodome, is paying the state about \$2,000 for the marker.



The Astrodome Conservancy also is planning a public event at the stadium. Previously, the organization announced a bash for April 9, but details are expected to be released next week.

“We are hoping to create a real party atmosphere to celebrate the history of the Astrodome and look forward to a bright future,” said Beth Wiedower Jackson, the conservancy’s executive director.

The Dome has not housed a professional sports team since the Astros moved to Minute Maid Park in 2000. NRG Stadium opened in the Dome complex two years later to serve as the home of the National Football League’s Houston Texans.

The Houston fire marshal’s office declared the massive building unfit for occupancy in 2009.

The county spends about \$170,000 a year to maintain the Dome in NRG Park, located on South Loop 610 between Kirby and Fannin — largely for electricity bills and flood insurance. The renovation costs will be paid from the county’s general fund, largely made up of property tax revenue, hotel occupancy taxes and parking revenue, county officials have said. (Courtesy chron.com)

The U.S. Senate has voted 97-2 to advance the Stop Enabling Sex Traffickers Act, a controversial initiative meant to crack down on sex trafficking on the internet. The bill will now go President Trump's desk for his signature. Passage of the bill addressed concerns from the tech industry and capped off a months-long legislative fight.

The legislation, called the Allow States and Victims to Fight Online Sex Trafficking Act (FOSTA), but also referred to as SEXTA after the original Senate bill, would cut into the broad protections websites have from legal liability for content posted by their users.

The bill would hold websites liable for hosting sex trafficking content by making a change to a key part of the Communications Decency Act. Some free-internet activists — as well as some tech company representatives — have argued that the bill places an unrealistic burden on small website operators, and will ultimately chill online speech. Sex workers have also opposed the legislation. Sen. Ron Wyden (D-OR), a critic of the bill, offered an amendment that might have clarified the bill's purposes, but it was voted down.

“Today is a dark day for the Internet,” the Electronic Frontier Foundation tweeted, saying that the legislation “will silence on-line speech by forcing Internet platforms to censor their users.”

Last month, the House of Representatives passed its version of the legislation. Fol-

# U.S. Senate Passes Controversial Online Sex Trafficking Bill

lowing the broad support in Congress, President Trump will likely sign the legislation when it reaches his desk, and Ivanka Trump gave the measure her support yesterday. “Passing this important piece of legislation will bring us one step closer to ending sex trafficking online & restoring safety in our communities,” she tweeted. “We now have the ability to go after these websites who are exploiting women and children online,” Sen. Rob Portman (R-Ohio), one of the original authors of the bill, said at a press conference after the vote.

The House overwhelmingly passed the bill last month, and President Trump is expected to sign it.



The legal liability protections are codified in Section 230 of the Communications Decency Act from 1996, a law that many internet companies see as vital to protecting their platforms. SEXTA would amend that law to create an exception for sex trafficking, making it easier to target websites

with legal action for enabling such crimes. Wyden, the most outspoken critic of SEXTA and one of the authors of the Communications Decency Act, said that making exceptions to Section 230 will lead to small internet companies having to face an onslaught of frivolous lawsuits. “In the absence of Section 230, the internet as we know it would shrivel,” Wyden said on the Senate floor ahead of the vote Wednesday. “Only the platforms run by those with deep pockets, and an even deeper bench of lawyers, would be able to make it.”

The Oregon Democrat also noted opposition from groups as varied as the Cato Institute, the Human Rights Campaign and the American Civil Liberties Union.



But some lawmakers and anti-sex trafficking advocates think the law has gotten in the way of efforts to go after online trafficking suspects like Backpage.com.

Sen. Richard Blumenthal (D-Conn.), a co-author of SEXTA and a former prosecutor, called Section 230 “outdated and obsolete” during Wednesday’s press conference.

Most internet giants have gone quiet in the fight over the controversial bill. Facebook endorsed SEXTA as the company faces scrutiny on other fronts, in particular alleged Russian efforts to use their platform to conduct a disinformation campaign targeting U.S. voters during the 2016 election season.

But the bill was also championed by technology companies, such as IBM, Oracle and Hewlett Packard, that have been at odds with Silicon Valley. They argued that online companies enjoy overly broad legal protections while being subject to very little regulation, leading to pervasive problems like online sex trafficking.



The passage of the bill is widely seen as a major legislative loss for Silicon Valley, and perhaps the first in an era where the industry is being viewed much more critically by lawmakers.

During Wednesday’s press conference, Sen. John Thune (R-S.D.), the chairman of the Senate Commerce Committee, said he believes the bill sends a message to tech giants.

“I think that in the future tech companies have to understand that it’s not the Wild West and they have to exercise responsibility,” Thune said. (Courtesy thehill.com)
